## Alternating Pressure Pump & Bubble Pad

### User Manual

#### Standard Features

- ◆ Simple to operate.
- ◆ Portable and lightweight.
- ◆ Pad consists of 130 bubble cells.

#### Operating Instructions

1. Position pump on horizontal surface or hang it with the hook.
2. Open mattress on the bed. Secure it with end flaps or straps. Air tubes must be at foot of bed.
3. Connect air feed tubes to air outlet on the mattress and pump, ensuring that the tubes are not kinked or twisted. Allow space for bed rails to drop freely.
4. Plug the pump into a suitable electrical power source and switch on. The switch indicator should now illuminate.
5. Allow 20 minutes for mattress to inflate fully.
6. Cover with a sheet and tuck loosely.
7. Please use pressure adjustable knob to give maximum patient comfort.
